Ragging, according to Supreme Court of India, is a crime which destroys the physical and emotional confidence and it led to an increase in suicide activities. It is a disturbing reality in the higher education system of our country. Government /University Grants Commission (UGC) guidelines notified vide no. F.1-16/2009 (CPP-II) dated 21-10-2009 on Curbing the Menace of Ragging in Higher Educational Institutions, 2009 (Under Section 26(1) (g) of the University Grants Commission Act. 1956) are strictly implemented at Lumding College. According to the Hon'ble Supreme Court of India and UGC Regulation on curbing the Menace of Ragging in Higher Institutions, 2009. Ragging constitutes one or more of any of the following acts which may cause or is likely to cause physical or psychological harm or to arise fear or apprehension thereof in a fresher or a junior student:

- a. Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student.
- b. Indulging in rowdy or indiscipline activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student.
- c. Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresh or any other student.
- d. Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher.
- e. Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
- f. Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students.
- g. Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person.
- h. Any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student.
- i. Any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority of superiority by a student over any fresher or any other student.
- j. Any Act of Wrongful Confinement. Kidnapping, molesting or committing unnatural offences, use of criminal forces, trespass or intimidation.
- k. Any unlawful assembly or conspiracy to ragging and any Act of injury or infringement of the fundamental right to the human dignity



Measures to prevent Ragging & Other Harassment

Lumding College has taken following measures to curb the menace of Ragging and other Harassments from the Campus.

- a. Students and parents submit 'Anti-Ragging Undertaking' to the institutions at the time of admission.
- b. Timely reconstitution of Anti-Ragging Committee to ensure compliance with the provisions of the Regulations as well as the provisions of any law for the time being in force concerning ragging; It will also to nominate, monitor and oversee the performance of the Anti-Ragging Squad in prevention of ragging in the institution.
- c. Anti-Ragging Squad under the guidance of Anti-Ragging Committee which is also reconstitute time to time, will be called upon to make surprise raids on hostels, and other places vulnerable to incidents of ragging and other Harassments. If there is any Case, the Squad shall be submitted its report along with recommendations to the Anti Ragging Committee for action.
- d. Awareness campaigns and programs on Anti-Ragging and Sexual Harassment are conducted for fresher and senior students every year.
- e. Boards displaying the Anti-Ragging and Sexual Harassment regulations are exhibited in the prominent places in the campus and hostel and on the Institute's website.
- f. CCTV cameras are present at all vital points of the institute where the menace can be initiated.
- g. Students can make use of the suggestion/ complaint boxes placed on the different sections of the campus to make their complaints regarding ragging.
- h. They may also approach the members of the cell or any of their other teachers as it comfortable to them or can call or mail to the contact details displayed in the boards.

Punishment to Those Found guilty.

Any student or group of students found guilty of ragging in the campus or even outside the campus, depending upon the nature and gravity of the offence as established, shall be liable to any one or more of the following punishments:

1. File a complaint with the Police Authority.
2. Suspension from college/hostels for a period of one month.
3. Withholding/withdrawing scholarship/fellowship and other benefits.
4. Suspension from attending classes and academic privileges.
5. Debarring from appearing in any Test/ Examination/Placement or other evaluation process.
6. Withholding results/ Debarring from representing the institution in any regional. National or international meet, tournament, youth festival etc.
7. Expulsion from the institution and consequent debarring from admission to any other institution.
8. Fine ranging between Rs. 25,000/- and Rs. 1,00,000/-.

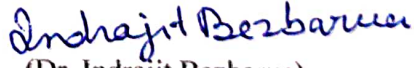
The first meeting of the reconstituted Anti Ragging Committee, Lumding College, Lumding has been organized on 11. 5. 2022 at 2 PM in the Principal's chamber and chaired by Dr. Mrinal Kanti Paul, Principal, Lumding college and conveyed by Dr. Indrajeet Bezbarua, Convenor of the Committee and attended by all the hon'ble members of the committee signed at the resolution book at the Conference Hall. At the beginning of the meeting, the Convenor read out the policies of the Committee for necessary approval. Accordingly, all the members of the committee unanimously approved all the policies. Under the Chairmanship of Principal, the meeting started to evaluate the running of the Anti-Ragging Committee and Anti-Ragging Squad.

The meeting evaluated the progress of the Committee and found that the committee and the squad are actively engaged in maintaining the campus ragging free. Regarding matter relating to complaint, there was no such case before the committee till date showing that the college campus is free of ragging and the college is still maintaining the status. The members of the committee participated in the discussion as per agenda and the following resolutions are taken in the meeting:

1. Resolution No. 1: The meeting read and confirmed the minutes of the previous committee and found that the committee worked hard to keep the campus ragging free as there are no serious complaints registered with the committee in the previous academic year.
2. Resolution No. 2: The meeting approved the inclusion of new Students' representative of the AY 2021-2022 in the committee for better working environment. It is also decided to reconstitute the Anti-Ragging Squad for the AY by including the new students' representatives. The squad will tighten the vigil of the committee with the support of the squad. The new Squad will be responsible for the overall monitoring and supervision of the ragging prone areas in the campus.
3. Resolution No. 3: The committee decided to conduct an 'Anti-Ragging Awareness Campaign' for the students in two sessions: Campaigning by senior students of the college for the students of the first semester and special session to the third semester and fifth semester students by the Convenor of the committee.
4. Resolution No. 4: It is further resolved that the committee will arrange two meeting in one academic year to evaluate its working and also if any case reported to the committee by the students or by the Anti Ragging Squad.

As there were no other items for discussion the meeting ended with vote of thanks and regards by the Convenor.
