The Memorandum of Understanding (herein after referred to as 'MoU') is made and entered into:

2. Lumding College, Lumding, Hojai, Assam-782447 (herein after referred to as LC or the First Party) represented by Dr. Mrinal Kanti Paul and includes their successors.

And

2. Lumding Municipal Board, Lumding, Hojai, Assam-782447 having their office at Lumding, Hojai, Assam-782447 (herein after referred to as LMB or the Second Party) represented by Chairman Lumding Municipal Board, Lumding, Hojai, Assam and includes their successors.

LC and LMB (collectively referred to as Parties) have agreed to work together for the maintenance of cleanliness of Lumding College campus through regular storage, collection, disposal, segregation and treatment of wastes.

4. **Term:** This MoU is effective upon the day and date last signed and executed by the duly authorized representatives of the Parties to this MoU and shall remain in full force and effect for three years from the effective date.
5. **Objective:** The objective of this Collaboration is to impart and maintain the cleanliness of the college campus and surroundings of the college. LC will regularly collect wastes and segregate waste from within the campus and place them in storage Hut. LMB will carry and transfer the collected non-biodegradable waste to Lumding Municipal Board Waste Dumping place for further segregation and treatment. non-biodegradable solid waste from the first party at regular intervals. LMB will collect non-biodegradable solid waste form the storage hut twice every month at a

fee as per **Municipal Board rate**. Further, the objective of this Collaboration is to work jointly to make the college campus a free plastic zone and to protect and preserve the green coverage.

6. **Termination:** This MoU may be terminated, without cause, by any of the parties upon 30 days' written notice, which notice shall be delivered by hand or by online mode. The parties may withdraw from this understanding with immediate effect by mutual consent.
