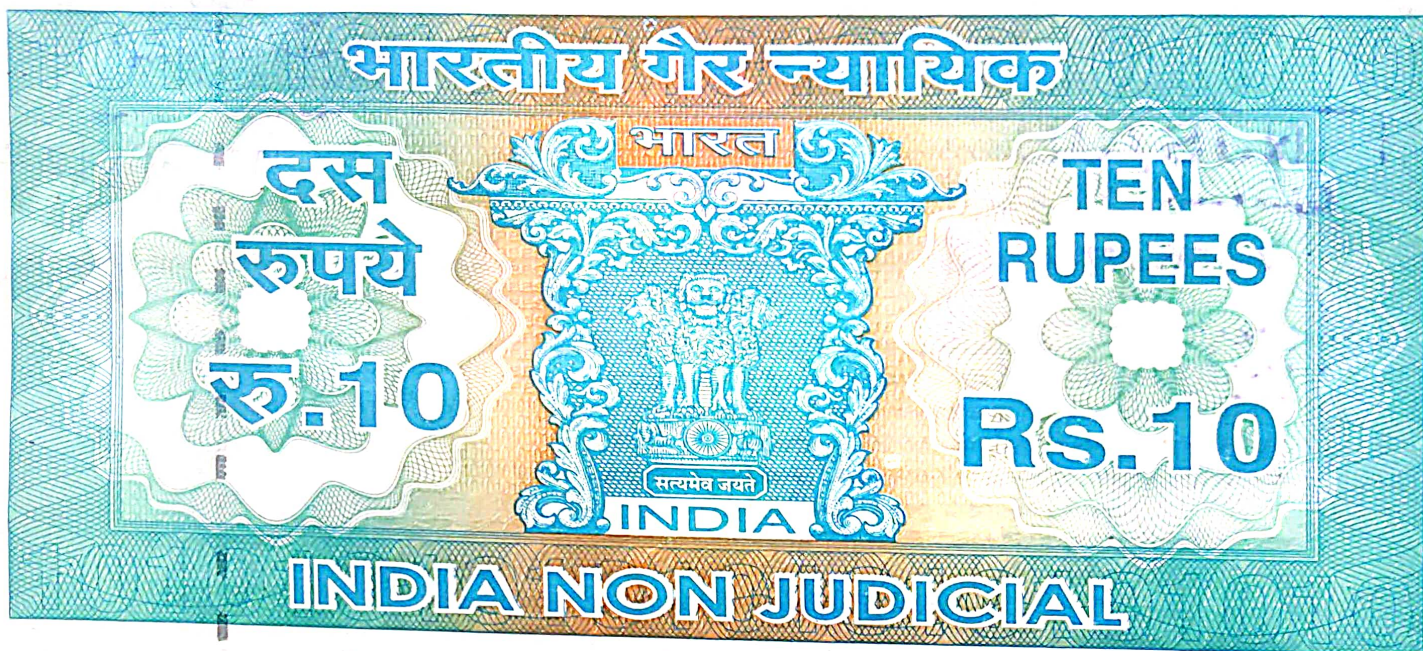

MEMORANDUM OF UNDERSTANDING

Specific issues, terms and conditions will be mutually agreed upon & settled on case to case basis depending upon the successful feasibility of the given task. This Memorandum of Understanding Cum Inter-Se Agreement shall take effect from the date of its execution, as

mentioned herein below and shall remain in effect for three years henceforth. It is also agreed and understood that either party to this Memorandum of Understanding Cum Inter-Se Agreement may, at any time, terminate this Memorandum of Understanding Cum Inter-Se Agreement. Although such action will only be taken place after mutual consultation with each other.

Both the parties to this Memorandum of Understanding Cum Inter-Se Agreement hereby mutually agree to the following terms and conditions:

1. The venue of Coaching will be Shelly's Coaching Centre, Lumding.
2. Students of Lumding College, Lumding shall be provided with discount of 30 percent on the joining fee and 10 percent on monthly fees for getting sports coaching and enrolling in the Gymnasium. However, to encourage the students of Lumding College, Lumding, who come from economically weaker sections of the society, higher discount of 30 percent on joining fee and 20 percent on monthly fee shall be given.
3. The coaching timings for the students of Lumding College, Lumding are to fixed by the Shelly's Coaching Centre, Lumding but shall not have any clash or conflict with the pick normal study schedule of the Lumding College, Lumding.
4. Lumding College, Lumding, appoints Sri. Pradip Bahadur Chetry, Assistant Professor and Convenor of Sports Committee, Lumding College as liaison teacher to monitor the activities under this Memorandum of Understanding Cum Inter-Se Agreement.

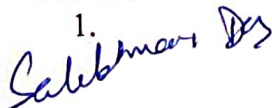
